

## 1400 Christmas Trees Ordered; Sign Up for Your Shifts in Late October

Ken Scharer, chairman of the annual Christmas Tree Sales project, advised the membership that the committee had its first meeting and had placed the order for Christmas trees. This year, he said, we have ordered 1400 trees from Cascade West and will be doing business with only one supplier.

Using only one supplier, rather than two or three as in the past, makes it much easier to handle, Ken said.

Also, he added, the club has been able to get a better deal on price and consequently, "the bottom line is we should be able to net \$7,000 more this year."

The sale of Christmas trees is our biggest fund raiser and allows us to follow through on the club's mission statement to help the children and youth of our community.

The Christmas Tree lot again will be located on Vineyard Street next to the Healdsburg City Hall and will probably open just after Thanksgiving which this year will be celebrated on November 27.

Ken said that the sign up sheet indicating the shifts for each day will be available in late October.

### No Action on Proposal To Raise Dues

The main topic of discussion at the September 11 board meeting was the proposal to raise the quarterly dues to meet the rising costs of the club's business and to cover the deficit.

Administrative treasurer Dennis Gary in a presentation and letter to the membership at the club's September 2 meeting pointed out that our dues cover about 70% of administrative costs, creating a deficit of approximately \$23,000. Fund raisers such as the August BBQ reduce the deficit and provide about \$10,000 annually. He pointed out that the administrative costs are relatively fixed and difficult to be reduced. Other fund raisers to help with the costs are contemplated such as a dinner at a local winery.

However, even if we can raise more funds this way it is inevitable that rising costs will add to the problem , he pointed out. Meals constitute our biggest expense . However, it was deemed that we should not try to reduce the quality of the lunches.
