Board of Directors Meeting

Summarized from minutes by Liz Bippart

The October Board meeting was canceled because of the wildfire evacuation.

Meeting Programs

Oct 1: Dick Bugarske – Management of Club funds

For the October 1 program, Dick presented a "Proposal to Keep Our Club Healthy, Prosperous, Vital, and Prepared for Our 100thAnniversary on Nov. 3, 2023.

The proposal will be presented at the next board meeting. It considers the allocation of our fund-raising monies to our 4 separate funds and the disbursement of the funds to our various benefactors and keeping our administrative fund healthy. Here is a summary of Dick's proposal:

HHS Scholarship Fund:

(\$443,000 as of August 2019)

A 501(c)3 Fund earmarked to provide scholarships annually to HHS graduates.

An event where we solicit tax-deductible sponsorships:

• June: Fitch Mt. Footrace

Foundation/Project Fund:

(\$101,000 as of August 2019)

A 501(c)3 Fund earmarked for providing annual support for Key Club, Scouts, Dictionaries and requests from the community.

Events where we solicit tax-deductible sponsorships:

- March: St. Patrick's Day
- April: Pancake Breakfast
- September: Safety Fair
- November: Hall of Fame

Endowment/Legacy Fund:

(\$6,250 as of August 2019 - begun in 2018-19)

A 501(c)3 Fund earmarked for sustaining future funding for Kiwanis Youth Projects by creating an endowment fund similar to the Scholarship Fund.

An event where we solicit tax-deductible sponsorships

• August: Brandt's Beach BBQ

Administration Fund:

(Approx. \$45,000 flows through this fund each year.)

A 501(c)4 Fund earmarked for "sustaining" the Healdsburg Kiwanis Club, Kiwanis International, and providing support for local leadership, member training, and enhanced community involvement.

CEO, PDI Surgery Center

The PDI Surgery Center is a sustainable dentistry resource that serves the low-income children of Northern California who need safe sedation for dental treatment, and to provide prevention education and promote oral health.

The PDI Surgery Center is a specialized nonprofit dental facility treating children under anesthesia suffering from severe decay. Surgeries are performed under general anesthesia and



may include fillings, extractions, pulpotomies, and crowns.

Every year, PDI treats more than 2,200 lowincome children from 33 Northern California counties who are suffering such severe tooth decay that then require surgery under anesthesia. Their average age is 3 and the average number of teeth requiring treatment is 12.

Oct. 15 - **Dave Jahns** Recreation Manager and **Mark Themig** -Community Services Director - City of Healdsburg

Mark discussed the planning and goals for Arts and Culture activities. In accordance



with recommendations in the recent American Institute of Architects SDAT Report, the City has identified Arts and Culture as a focus area.

The City Council goals are:

• Embark on a community-based arts and culture plan that would gather widespread input about the role of arts and culture in the life of the community... Use the information gathered to enhance the City's participation in expanding art in the City.

Dave presented an update of planning for new park development and redevelopment of existing parks.

The planning goals are:

- A master plan for development of the new 36acher public park that will be part of the Montage Resort development.
- A plan for future redevelopment of Badger Park that will focus on restrooms, creating river access, and other future improvements
- Working collaboratively with Sonoma County Regional Parks, evaluate options for enhancing access to the Russian River as it passes through Healdsburg.
- Developing a high-level plan for enhancing bike and pedestrian connectivity throughout the community.

Other guests at our October 15 meeting were **Jen Oberti** and **Cheyenne Halone** from Corazon Healdsburg. In a brief presentation they discussed the Corazon feature programs:

• Adult education held at the Healdsburg Community Center offers classes in English as a Second Language and preparation for the GED.

- FirstGen college Counseling helps prepare historically underserved Healdsburg high school students to become the first in their family to complete college.
- Comite, committee of active and engaged Healdsburg residents that meet monthly to discuss issues impacting Healdsburg's Latino community.

Oct 22: - Cindi Brown - Beekeeper

Our own Cindi Brown has been a beekeeper for about 2 years. Cindi is a lover of the planet and the plants on it and is unafraid of bees so becoming a beekeeper was a very good fit.



In a very interesting and informative presentation she showed us some of her equipment and explained the makeup of bee colonies and their life cycle. A bee colony consists of a queen bee, the only breeding female in the colony, a large number of female worker bees and a fewer number of male bees. The queen may live up to 5 years, but the workers only live and work for 4 to 5 weeks. The younger workers perform basic housekeeping: cleaning empty cells, removing debris, making wax for building comb etc. Older workers leave the hive daily and forage for nectar, pollen, water and propolis. They have a range of about a 2-mile radius.

The male bees have only one function, to mate with new queens and fertilize them.

A healthy bee population is very important for our agriculture. We can help bees by planting pollen producing shrubs and flowers, providing water and using non-toxic pesticides. **Oct 29**: Evening meeting - Halloween Game Night-Tricks and Treats

Safety Fair update

The Sonoma County Bike Coalition's Bike Workshop/Rodeo was one of the most popular events at the fair. Participants included 101 kids (between ages 9 Months and 16 Years) and 75 adults. 95 helmets donated by Healdsburg Kiwanis were given out to the kids. 68 of the kids rode bikes through the Rodeo course and learned about bike safety.
