The President's Message

Service - With A Smile

"So what does Kiwanis Do in Healdsburg?"

"Do you need to do anything special to become a Kiwanian?" So with a smile I respond that Healdsburg Kiwanis is a local service organization of over 80 members who raises funds for community needs. We donate over \$50,000 each year back to our community and annually provide \$12,000 to \$15,000 in scholarships to our local graduating seniors.

"So how much service do you do?"

Again with an even bigger smile I responded that I thought that our 80 strong members donated over 20,000 hours a year.

"How do you know that?"

So I asked Phil Luks if he could pass on to me the "Community Service Report" slips from September so I could "run the numbers".

Phil had 31 member slips.

The total hours noted were about 640 (not all writing was completely legible), which is an average about 21 community service hours per member for the relatively quiet month of September.

The number of local organizations served was 35 after combined duplicates.

So I took the liberty of using about 25 hours per month per member (some months are very busy for us) and came up with about 25,000 community service hours per year from our Club and adding another 15 groups, projects and organizations to the list of those served, I feel pretty confident that ("How do you know that?") can be answered by:

"Well, from data from our members, we provide about 25,000 hours of community service to about 50 groups and organizations in the greater Healdsburg area." Of course, stated with a smile.

Retired Fire Chief Randolph Collins Accepts Position With Junior College

If you've missed seeing Randolph Collins at meeting lately, there is a good reason.

A member of Kiwanis since September 2001 retired Healdsburg Fire Chief Randy Collins is now Director of Fire Technology at Santa Rosa Junior College. He oversees the entire Fire Technology program and teaches only "when he has to fill in for an absent instructor".

Randy retired as chief of the fire department in June of this year and served as Fire Chief since 2003 when he took over from then Fire Chief Bob Taylor.

Randy has had a 30 years career in firefighting with 23 of those spent in Healdsburg. While attending Humboldt State University he volunteered with the fire department and after graduating with a degree in industrial arts he took a position with a circuit board company and continued with volunteering as a firefighter. He decided after two years to pursue a career in fire science earning an Associate Degree. He accepted a position in Healdsburg's Fire Department in 1987, becoming a Captain in 1989 and Fire Marshall in 1990 when Kiwanian Bob Taylor became Fire Chief.

Randy has had a career in firefighting for 30 years and now in retirement continues doing the work to which he has devoted so many years.

Randy lives in Healdsburg with his wife, Darlene and children, Bill, 18 and Emma, 16. He is a long time member of St. Paul's Episcopal Church and devotes time to North County Community Services.

She reminded the members that our mission is to serve the children and to give back to the community.

Board Adopts A Policy Regarding Reimbursement of Club Expenses

"To Be Reimbursed for club expenses, club members must submit receipts to the club treasurer with 90 days from the date the expenses were incurred."

The above policy was adopted by the board of directors at the October 21 meeting held at the Healdsburg Police Station's Conference Room. In the board's discussion period it was noted that late reimbursement requests created fiscal planning problems. It was pointed out, further, that late requests "may lead to a lack of supporting documentation."

In other business, the board considered the \$5,000 PSST (Public School Success Team) request and it was agreed that, in place of last month's approval, the treasurer would be authorized to make grants up to the cumulative amount of \$5,000, based on specific requests and/or expenditure reimbursements communicated to the treasurer, Pete Peterson.

At the meeting Jane Rosenberg and B. Epstein made a presentation on behalf of PSST which at the September meeting had been conditionally awarded a \$5,000 grant for the 2010-2011 school year. The board was informed that the following were metrics associated with the first year of the program's efforts in one of Fitch Mountain School's fifth grades:

1. Teacher feedback from the current sixth grade teachers of last year is good.

- 2. 100% of the children participated and there was meaningful involvement by 70% of the families.
- 3. STAR test scores for the individual class involved and the individual children involved could not be publicly released. However, the number of children significantly exceeding basic language requirements increased from 12 to 17, and the number who were below requirements dropped from 12 to 4. In mathematics, the number exceeding went from 13 to 19 and the number below dropped from 7 to 2.

A new school year program will start both with another fifth grade and continue with last year's students. A summer program was also conducted last summer. It was also revealed that a local accountant had become involved in setting up the organization's books and accounts.

A request from Lt. Governor Eric Wheaton for \$1,230 (\$15 per member) as the club's contribution to Division 32 Lt. Governor's expense account was tabled until the board's November meeting. Lt. Governor Wheaton will pay a visit to our club on November 2 at which time his budget can be discussed.

The treasurer reported that there was approximately \$11,000 in unreserved cash in the Project Funds. The Administrative Fund, it was revealed, is in current good shape as a result of the Brandt's Beach Dinner and Auction and the Golf Tournament. However, reserves are required for year-end rent and first quarter Kiwanis International membership fees.

In a discussion regarding the members' grant preference percentage recommendations, it was decided that the Club's grants should be made predominately on a request basis rather than a budgeted basis.

A donation request from my.HBG.tv for \$400 was tabled with the suggestion that Mark Decker, chairman of the organization, should speak to the club in the first instance.

A request from the North County Realtors Council golf fundraiser to split the funds, \$2006, between the Food Pantry and Meals on Wheels was approved.

Rick Norman, Membership chairman, reported that attendance of the active as well as associate members at the evening meetings needed to be encouraged. It was agreed that additional email publicity should be undertaken and that e-mail signups for committee work and Christmas Tree lot work should be available by e-mail. Loretta Strong agreed to follow up on the potential for corporate memberships,

Treasurer Pete Peterson reported that the club's financial oversight committee (Dan Maraviglia, Cindi Brown and Charles Reichel, advisor) was about to review the club's books of account

Pete also notified the board that Kiwanis International has clarified that the insurance the club purchases from KI as part of its membership fees, \$12 per member per year, as well as the directors and officers' insurance the club purchases directly (about \$750 per year) can be paid out of either the Administrative or Project Funds, or split at the club's discretion. The decision will be made when these payments come due.

Loretta Strong advised that David Jones, chairman of the Fitch Mountain Foot Race, was in the process of coming up with a proposal to increase the size of the race and combine it with a "Celebrate Healdsburg" event in the Plaza Square. Income from the race is placed in the Healdsburg Memorial Scholarship Fund. A general discussion was held concerning the relationship between the Club and Memorial Scholarship Fund, and the various communication and governance issues associated with the separate yet overlapping nature of the two organizations. The Executive Committee will address this by year-end and Secretary Phil Luks will submit a memo outlining some of the issues involved (Phil Luks Contributed To This Article).

During the past month program chairman Hunt Conrad has presented a number of interesting speakers/programs. On October 5 the membership was introduced to the new principal of the Healdsburg High School, Chris Vanden Heuval whose last assignment was principal of the Windsor High School.

Nicole Young, a 16 year old high school student, at the October meeting gave the membership a fascinating account of her trip to Kenya where she spent two and a half weeks.

And on the following week Sonja Drown, Recreation Manager of the Healdsburg Parks and Recreation Department and Patty Morandi, Before and After School and Early Childhood Services Coordinator explained the many activities being provided by the Parks and Recreation Department to the youth of our community. The Department is now housed at the Former Foss Creek School located near the northern end of Healdsburg Ave near Grove Street.

Ray Holley and Jim Walters, representing the Alliance Medical Center, pointed out some interesting and startling statistics: a registered non-profit

organization, it was founded in 1971 by community volunteers to serve migrant farm workers and their dependents. It has grown so now there are three facilities – Healdsburg headquarters, a Windsor facility and a Teen Health Center. It has an annual budget of \$9.4 million, treats 13,000 patients and employees 110, the fourth largest employer in Healdsburg. Its service area is from Larkfield to Geyserville and Knights Valley to the Coast.


