

Board of Directors Meeting

Summarized from minutes by Liz Bippart

The following is a summary of actions taken and items discussed during the November 2018 Board meeting:

Grants/Donations/Requests

- Redwood Empire Invitational Basketball Tournament (REIBT) – \$200.
- HEF (Healdsburg Education Foundation) has offered to conduct a tour for 6-8 of our members of HHS where bond money has been spent to improve the culinary program, CASA (small houses), media production and other academic advances.
- Lt. Governor, Pennylee Christensen presented her budget at the recent DCM. We currently have 65 members in our club. At \$24 requested per member, we owe \$1,560 to help cover Pennylee's expenses this year.

Money Matters

- Admin Fund: Current balances - Admin Fund, \$8,350; Losh Fund, \$1,250; Reserve Fund, \$10,000; Strong Fund, \$106.
Dick recommended an increase in dues to build back the Admin Fund and avoid using the Reserve Fund. The new fees will be \$65 for non-lunch members per quarter and \$130 for regular lunch attending members. The Hall of Fame event earned \$600-700 for the Admin Fund; Brandt's Beach raised approximately \$13,000; plus the dues increase should allow the Admin Fund to remain in the black. Ron suggested that in the future we could attach dues to the cost of living index for annual adjustment.
- Project Fund: Current balances - \$5,933 checking; \$86,500 Money Market and none in the Reserve Account.
- Kiwanis Memorial Scholarship Fund: Balance \$430,00+ at the end of fiscal year 9/30/2018. This allows giving 3% in expected earnings or \$11,726 in scholarships this year. Chuck Reichel has recently resigned from the Scholarship Committee and a replacement board member is needed.
- The Board adopted a resolution authorizing the treasurer to transfer the project funds from the

club's project fund accounts to the Healdsburg Kiwanis Foundation and to close the project fund accounts when completed.

Committee Reports

- Kiwanis Project Fund Sub-Committee: The committee has been discussing what to do with our current Project Fund balance while considering the reduction in forecast income and propose a total annual project spending amount. Their recommendation:
 - A. Reserve \$75,000 of the current Project funds to be allocated to project spending over the next 5 years at the rate of \$15,000 per fiscal year.
 - B. Set aside \$5,000 to seed the creation of an endowment fund supporting the youth of Healdsburg, details to be determined.
 - C. Set aside the remaining Project funds, approximately \$10,000 as an unallocated reserve.

Other Business

- Anita Kratka has proposed a joint fundraising event at Baci restaurant for Kiwanis of Healdsburg and Prune Packers. Up to 80 people can attend this private party. We would sell tickets for \$150 per person. May 15th is the proposed date and will be checked for conflicts with other events in Healdsburg. Live auction items will be available. Anita proposed that 1/3 of the proceeds would go to Prune Packers and 2/3 would belong to Kiwanis. Wine donations will be solicited.

Meeting Programs

Nov. 6: - Glen Schaezlein, HUSD Supervisor, Maintenance and Operations

As HUSD Supervisor, Maintenance and Operations Supervisor, Glen Schaezlein has many responsibilities, but one of the most important is to make sure that available bond money is spent in accordance with the intent of the voters.

Glen discussed the various enhancement projects completed and planned at Healdsburg schools financed by the recent \$100,000 issue passed by the voters. Glen was happy to report that the

recently completed state-of-the-art track and synthetic multi-sport field at Healdsburg High was completed on time and about \$2 million under budget. Other projects include the recently completed remodeling of Smith Robinson Gym and upcoming projects: a new gym at Healdsburg High and remodeling the gym at Healdsburg Junior High.

Nov 20: - Anna Grant - Healdsburg Senior Center

Anna Grant is the Active Adult & Senior Services Supervisor (AASSS) for the City of Healdsburg. As our speaker on November 20, Anna discussed three subjects: herself, the Senior Center and broader community and toilets.



Originally from San Diego, Anna attended Dominican University, San Rafael and received a BA in psychology, emphasis on animal behavior. She started working with disturbed youth and also worked with seniors. She worked 10 years in the senior living industry and joined the City of Healdsburg in June '17 and has been "hanging out with my seniors and working for the broader community".

The Senior Center is not just for old people, there is no age requirement. It is not all bingo, but has exercise classes, sport teams, fitness and educational classes – many at low or no cost options. Other programs include bus trips to interesting places departing (almost) monthly and bistro dining.



The Volunteer Drive Program is a multifaceted program that will capture the generous spirit of the Healdsburg community, providing residents an avenue to give back to their community. It will be a single outlet for volunteerism in the community and support for new and existing City volunteer opportunities.

And toilets: Health checks from your doctor could be replaced by visits to the bathroom, thanks to a smart toilet developed by a Japanese company. The "intelligent Toilet system created by Toto will measure sugar levels in urine, take blood pressure

and weigh body fat and weight. Once results are taken, they are transferred to a home network, and analyzed on a computer spreadsheet.

First Book Project dictionaries available for distributed to third graders

The Healdsburg Kiwanis First Book Project for 2018 has been delayed due to school disruption caused by the wild fires and smoky conditions. The dictionaries have been purchased and are on hand for distribution during the first week in December. A total of 190 dictionaries were obtained from Costco at a significant discount (\$16.27 vs. \$26.75 list price). The total cost to the project fund was about \$3093.


