#### The President's Message

Happy 90<sup>th</sup> Birthday Healdsburg Kiwanis Club

It was the year 1923. The United States was enjoying prosperous times between World War I and the depression years that were to follow 1929.

It was the year Calvin Coolidge became President and marked the beginning of the Golden '20's, a period in which the United States Government collected more money than it spent and actually paid off some of the national debt.

In early June 1923, two men arrived in Healdsburg with the intention of forming a Kiwanis Club in the community.

Nathan Combs, Napa District Attorney, and Frank Kean, the State Organizer for Kiwanis, had come to tell the story of Kiwanis. Napa had organized a club in 1922, and was anxious to sponsor other clubs in the North Bay area. They met first with Joe Miller, George Imrie, Dr. Julian Wright, and Fred Young.


At a later meeting on June 25<sup>th</sup> at the American Legion Club House there were 15 members of the Napa Kiwanis Club present and the story of Kiwanis again was told to a larger group of local business and professional men

On June 29<sup>th</sup>, 1923, a meeting was held and the following permanent officers were elected: Joseph Miller, President, George Imrie, Vice President, Charles Comstock, Secretary, Mike Cummings, District Trustee, and George Hayes, Treasurer.

The Healdsburg Kiwanis Club was chartered on November 3, 1923 with 60 members. The principal reason for Kiwanis then was to render service to the community and it didn't take long for the Club to get down to real business and begin the legacy of community service.

Meetings were held in the Plaza Hotel dining room during the first year of existence. Meetings were moved to the American Legion Hall in the winter of 1924.

On our 90<sup>th</sup> birthday, we honor our founders and celebrate the thousands who have made the Healdsburg Kiwanis Club such a great and lasting organization. We look forward to our 100<sup>th</sup> anniversary in 2023 and many more anniversaries into the future.



#### **Board of Directors October Action**

The following are actions taken and items discussed during the Board meeting on Thursday October 17, 2013.

The following grant requests were approved by the Board:

- Healdsburg Regional Library, Children's Department - \$2,000 approved for specific improvements and additions in both fiction and non-fiction Children's Books: Transportation (cars, trains, tractors, trucks, boats and planes); Animals (Horses and pets) and Dr. Seuss picture books. Some books will be new and others to replace older "well used" books.
- California Assoc. Of Student Councils (CASC) -\$300 approved for ten \$30 "Scholarships for Young Leaders of CASC" for attendance at a CASC Conference. The student Young Leaders are Healdsburgians.
- AAUW Science Camp for Young Women -\$900 approved for 7th Grade Healdsburg students to attend Science Camp at Stanford University.

In other action a \$1,000 Grant Request to help publish the local Kid Scoop News was tabled for the second time to request more data. Currently the Kid Scoop News is delivered to approx. 20 Healdsburg Elementary school rooms.

The 3rd Grade Dictionaries are on hand and ready for distribution. Treasurer Pete was granted approval to pay the bill. Ten to twenty Key Club members who have received 3rd Grade dictionaries in years past will help with the distribution. Kudos to them!!!

Tabled for further discussion on the selection of deceased members for a Club financed memorial and the amount payable for such memorials.

The Board approved the Tree Lot Committee's request to require:

- Three shift mandatory signups;
- A \$30 Missed Shift fee to help offset cost of hiring replacements;
- Collection and accounting for such Missed Shift fees are the responsibility of the Tree Lot Committee; and
- A list of Shift Non-Available Members for reasons such as health to be developed by the Tree Lot Committee.

#### **Financial Statements Now Available**

Treasurer Pete Peterson has completed Club Administrative and Project Funds financial statements for our fiscal year ending 09/30/2013 and they have been emailed to members.

#### **October Programs**

Gisela Zebroski - Author of "The Baroness" and "Mephisto Waltz"

Gisela Zebroski spoke at our October 1 meeting about her early life experiences as a refugee in Europe during and following World War II and her career as an author.

Gisela was born in Latvia. At the outbreak of WW II the family was evacuated to Poland but not for long. They fled West when the Soviets broke through the German lines. In Austria she was saved by a British officer who had occupied the Alpine village where they hid out from the bombs. It took nine years before she could get on a boat to America which has been her homeland ever since.

Her Books, "The Baroness" and "Mephisto Waltz" are based on the life experiences of Gisela and her family who were Baltic Germans, an ethnic minority.



"The Baroness" is a historical sage spanning 1914 to 1925. Baroness Elisa, mother of five and wife to an influential Baltic German statesman enjoys the glamour of the Russian Empire - and the thrill of an affair with the dashing Count Baranowsky. But World War I and the rise of communism soon erode her world.

Mephisto Waltz illuminates the different worlds living side by side without taking notice of each other. There is Soviet occupied Germany, Allied occupied Germany, Switzerland and life on an American base in the midst of defeated Germany as compared to New York and Los Angeles.

#### Dan Maraviglia & Hunt Conrad - Healdsburg Kiwanis Legacy Program

Dan Maraviglia and Hunt Conrad, the speakers at the October 8 meeting described the Healdsburg Memorial Kiwanis Scholarship Fund and the Planned Giving Legacy program. The Fund is a separate 501(c)(3) non-profit entity founded in



1992 and managed by a separate Board of Directors. Members of Healdsburg Kiwanis Club are automatically members of the tax-exempt charity. The Fund is invested in three diversified, conservative, and well-managed funds in a ratio of US Equity stocks to

corporate and municipal bonds of 60% to 40%. The Board makes no individual investment selections. The Board has positioned itself to make available to the Scholarship Committee at least 3% of the last three years rolling average of total assets. The Scholarship Board is governed by the dictates of its governing charter, which allows only income to be paid out for scholarships.

The fund currently has approximately \$275,000 in invested assets. A total of about \$81,000 has been given out in scholarships since 1996.

The scholarship Planned Giving Legacy Program Is an excellent way to make a difference and leave a lasting impact by making a bequest. The program is described in a separate flyer inserted in this newsletter.

#### **Shelley Anderson - HHS Internship Program**

Our speaker at the October 15 meeting was Shelley Anderson, Coordinator of the Healdsburg High School Internship Program.

The objective of the program is to place the students in the program for a meaningful experience and prepare them for the work world. The program



provides mentors for all of the some 160 Healdsburg High School juniors in a meaningful internship assignment with a sponsoring organization. The students complete a career assessment and based on their skills and interests are matched with the best organization and assignment. The students spend five Tuesdays at the sponsor's work site working on meaningful assignments Students must keep a weekly journal of activities and reflections and at the end of the program deliver a presentation on the assignment, organization and personal experience.

#### Pamela Swan, Healdsburg Education Foundation

Pamela Swan, executive director of the Healdsburg Education Foundation (HEF) was the guest speaker at the October 22 meeting. Ms.



Swan expressed appreciation for past Kiwanis support and noted that our club has contributed about \$70,000 since 2007 in support of various HEF projects such as the lap top computer program, CASA and several others.

HEF goals for this year focus on retaining vital programs, increasing innovation and increasing parent involvement. The programs and funding needs include the Pasitos Project – Early Childhood Education (\$17,000), Parent Involvement fro Quality Education (PIQE) (\$8,000), Accelerated English Language Instruction (\$40,000), the Career Preparation and Leadership Academy (\$7,000), the Internship Program

(\$22,000), the K-5 Enrichment Program (\$70,000), K-12 Music and Art (\$40,000), and K-12 Library/ technology (\$100,000).

HEF will be submitting a grant request asking Kiwanis Club support for the Internship and Library/Technology Programs.

#### Ray Holley – CASA Program

Ray Holley was also a guest at the October 22 meeting. He gave a brief update of the CASA program and presented the club with a new gavel in the form of a large carpenter's claw hammer in appreciation of our support of the CASA Program. The program has grown to three classes this year with a total of 70 students. The senior class is starting another Tiny House. A new instructor, a credentialed teacher highly qualified for the program has been hired.

### Jeff Harding and Annie Millar, Healdsburg Unified School District

Jeff Harding, Superintendent of Schools and Annie Millar, Director of Curriculum, guest speakers at the October 29 meeting spoke about improvement and reform of public school education. The mission of the school district is simple: "All students will



graduate from our schools well prepared for college, career and Citizenship". Today's students will graduate into a competitive work environment far more demanding than prior generations. Skills needed in today's work world include ability of communicate ideas orally and in writing, solve complex problems, present persuasive arguments, and navigate a complex, data-rich world.

Curriculum is set up with a view to connect schoolwork with the real world. Programs to accomplish this goal include wellness, culinary arts, farm to table, garden/nutrition, and internship (see above). The work is hands on with students working in teams and encouraged to ask or find out why.

### **Planned Giving**

What is your legacy?

We all desire significance- to lead happy and fulfilled lives surrounded by family and friends. For many of us, there is a compelling need to make a difference- to leave a lasting impact on the people most dear to us and in the world in which we live

The search for significance and desire to plan for the future leads many to ponder their legacy. What kind of legacy will you leave?

An easy gift to make:

A charitable bequest is an instruction that directs a gift to be made to a qualified tax exempt charity when you pass away. It can be made in writing, by a will, trust, or beneficiary designation. One benefit of a charitable bequest is that it enables you to further the good work of an organization you support, like Kiwanis, long after you are gone. Additionally, a charitable bequest may help you reduce estate taxes by providing your estate with a charitable deduction for the value of the gift.

A bequest is one of the easiest gifts to make. With the help of an advisor, you can include language in your will, trust, or beneficiary designation specifying a gift be made directly to the Healdsburg Kiwanis Memorial Scholarship Fund. A scholarship in your name will be given to a deserving high school student to help with the next stage of their education. Your gift will be held in a trusted investment management fund and administered by the highest level of fiduciary responsibility by the scholarship fund committee.

A bequest can be made in several ways:

- Gift of a percentage of your estate
- Gift of the residue of your estate
- · Gift of a specific asset

Other Types of Bequests

Certain types of property pass outside of a will or trust. These assets require that you name a beneficiary by completing a beneficiary designation form. To make a bequest of these assets, you should contact the company or entity form which you purchased the asset. Here are a couple of examples<sup>1</sup>:

An insurance policy makes a nice bequest to charity. As an asset of your estate, an insurance policy is taxable at your death. However, if the policy is gifted to charity, your estate avoids paying tax on the value of the policy and receives a charitable deduction for the gift. You may generally name anyone as a beneficiary of your insurance policy and change your designation at any time. Contact your insurance company to obtain a beneficiary designation form and make a bequest of your policy to The Healdsburg Kiwanis Memorial Scholarship Fund.

#### Bequest of and IRA

A retirement asset like an IRA account makes an excellent bequest to charity. If the IRA was given to your family, much of the value would be depleted through estate and income taxes. By designating a charity as the beneficiary of part or all of your IRA, the full value of the gift is transferred tax free at your death and your estate receives the charitable deduction of your account. Contact your IRA or retirement account custodian to obtain a beneficiary designation form to make a bequest from your IRA to the Healdsburg Kiwanis Scholarship fund.
