**Object 6**: To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and goodwill.

As your President, I would encourage you to regularly reflect on these objectives, especially when asked to participate in a club activity be it a work party, Inner-club, Key Club event, fund raising activity or something as simple as serving as a greeter. #### **Board of Directors Meeting**

Summarized from minutes by Liz Bippart

The following is a summary of actions taken and items discussed during the Board meeting for October 2016:

#### Presentations to Board

Lt. Edith Mabie presented background information on the GED program at The Salvation Army ARC that provides necessary tools for assisting men in moving forward and attaining upward mobility in their lives. A certificate or diploma is a sign of dedication and discipline, increasing selfconfidence from achieving a goal. Last year 8 out of 10 at-risk men passed the required tests. On average 12-15 men take part in the program annually.

Annual expenses include: \$7,680 for teaching staff plus \$140 per man for each set of 2 tests required. Ten men are likely to need testing for the year. Therefore, the yearly cost would be \$7,680 for teaching staff plus \$1,400 for testing = \$9,080. Due to the possible sale of the ARC real estate and relocation of the ARC away from Healdsburg, Lt. Mabie's request is for quarterly support (\$2270).

Grant requests and expenditures

- The Salvation Army ARC \$1135 quarterly for GED support contingent upon matching funds from Rotary or other service clubs.
- Healdsburg Bulldogs (Youth football for ages 5-15) - \$375.
- Tech Trek AAUW sponsored tech conference at Stanford University for girls \$850 for one attending student.
- Key Club \$2,500 support this year to cover cost of snacks at meetings and various other expenses.
- HHS Boosters No specific request was received; however, 7 donation options are available with a maximum \$2,500 and less. Deferred pending budget completion.

#### Other discussion and action

**New Year's Eve Party:** The following expenses have been paid to date:

To date, 8 full tables for 8 people have been sold and another 5 tables are awaiting confirmation. There is space for 25 tables. It is expected that sales will start to increase as more people begin to think about making New Year plans. If we cancel now the financial loss will be approximately \$4,700 in nonreturnable funds. If we move forward, the additional expense will be \$2,000. Many planning hours have already been spent by Rick Anixter, Denny Stead, and other members of the committee thus far. The committee is expecting a sellout if the club gets on board to make it happen.

With a goal of selling at least 20 tables by the next meeting, the Board will review the numbers for a final go/no go decision.

#### **Meeting Programs**

October 4: Chris Vanden Heuvel - Supt. HUSD

Healdsburg Unified School District Superintendent Chris Vanden Heuven, guest speaker at our October 4 meeting outlined the recent physical improvements made at the high school and jr. high school campuses financed by the 1912 Measure E bond funds. He also discussed additional planned improvements to be undertaken financed by Measure D in the upcoming election, if passed.

Recent improvements at the HJHS include upgrading classrooms, construction of 7 new ones, and complete new wiring for technical equipment. Improvements at HHS include a new STEM center, a digital media lab, culinary arts center, and science center upgrade including an outdoor learning area.

Measure D is a \$67,000,000 bond issue to provide funds for:

- Science ed.: Farm to Table, STEM, agriculture science.
- Arts: Band room, Performing Arts Center.
- PE: New field turf, locker rooms, gyms, wrestling building.
- General maintenance: Roofing, plumbing, HVAC.

#### October 11: Lt, Governor Rich Fuller

Rich Fuller in his first visit to our club as new Lt. Governor, summarized the requirements of the *Kiwanis Youth Protection Guidelines* that we are all expected to read, understand and agree to.

**Background checks** are required for any member serving as a Kiwanis advisor to any Service Leadership Program club (Aktion Club, Circle K, Key Club, Builders Club and K-Kids). Background checks should also be performed for all adults who will work directly with youth outside of the school.

**Overnight Stays**: While attending a Kiwanis event that requires overnight stay, adult chaperoning must include no fewer than one adult male for each 10 or part of 10 youth males, and one adult female for each 10 or part of 10 youth females.

**Transportation:** The rule of 3 applies. When transporting youth, the best practice is having three people in the car at all times.

**Reporting**: If a Kiwanian observes troubling behavior involving a youth at a Kiwanis event or becomes aware of a situation that is illegal or potentially unsafe for a young person at a Kiwanis event, he or she must immediately contact the appropriate personnel at the event and provide notification to law enforcement personnel as appropriate.

**Behavioral or Health Issues**: Kiwanians should refrain from counseling youth and should instead find, or assist the young person in finding, appropriate expert assistance.

**October 18:** Gail Jonas -No On Measure R Update.

At our October 18 meeting, retired attorney and local activist, Gail Jonas discussed the No on Measure R campaign.

David Mickaelian, Healdsburg City Manager and Karen Massey, Community Housing and Development Director, guest speakers at our September 13 meeting, described the City's objectives of the upcoming ballot Measure R and the recently approved Housing Action Plan(HAP). Measure R, if passed would amend the existing Growth Management Ordinance in a number of ways.

The No on R campaign objects to many of the proposed changes in Healdsburg's Growth Management Ordinance (GMO) approved by voters in 2000.

#### **Gut Buster**

Healdsburg Kiwanians will be manning the intersections on the morning of November 5 for the GutBuster Fun Run and Walk. The event will include three courses to choose from: a 3K flat course around town, the 10K around Fitch Mountain and a 12.5K partial trail course over Fitch Mountain.



The purpose of the run is to raise awareness of stomach cancer, the third leading cause of cancer death. Vern Losh, who recently lost a son to this terrible disease is spearheading this event,
