Board of Directors September Summary

from Minutes Provided by Loretta Strong

The following are actions taken and items discussed during the Board meeting on Thursday September 18, 2014:

The administrative and project fund financials were approved by the Board:

Administrative Fund Financials

- The final two months Villa rent have been paid to City Hall. Going forward rent will be paid to the Tayman Park Group and is likely to remain the same amount or perhaps less.
- Fund balance remains healthy.
- Currently 12 members are delinquent one quarter on their dues.
- Our current insurance coverage lapses at the end of October and effective November 1st will be provided through Kiwanis International as part of our dues payments.

Project Fund Financials

- Last month was a light transaction month.
- The intended amount of support to the Salvation Army memorial project in honor of Joe Engler was \$3500 which will be debited from the Project Fund available balance for this purpose.

Administrative Report

- A great time was had by all at our recent lunchtime visit to the Bear Republic in Cloverdale.
- The recent Lt. Gov. Installation was attended by the Giannis and the Strongs.
- The Giannis both attended the new Presidents pre-meeting which was conducted by the Key Club Lt. Gov. and Advisor and focused exclusively on the role of Key Club and our responsibilities as clubs to that endeavor. Jan commented that it was made clear that more participation was expected and needed from Healdsburg according to the Key Club District Advisor. Dick Bugarske expressed that he was aware of this perception and that at the current time our HHS Key Club participates at the local level at which they feel comfortable.

Other Discussion

Regarding the upcoming 100th Anniversary celebration of Kiwanis International in 2015: Thoughts included a possible 100th Anniversary Pancake Breakfast and that we utilize every event and media opportunity to telegraph our message of who we are and our place in history as this milestone approaches. Regarding the proposal by Hunt Conrad (See September 2 and 16 Meeting Programs below), to launch a bicycle tour for 2015: The big question remaining is who will do this? The manpower required and upfront seed money to execute the event are formidable. Some alternative ideas were discussed, but It was concluded that the Board would direct Hunt Conrad to further flesh out this proposal as a more cohesive package that possibly the club could execute under his leadership. The Board agreed it could not support this proposal for 2015 but might reconsider it for 2016 if provided with much greater detail and advance preparation.

Dan Gianni requested that the club advance market the upcoming speaker program by Mark Klaas of the Polly Klaas Foundation as a potential recruitment tool for guests and potential new members.

The written resignation of Mark Zimmerman effective 9/15 was approved.

September Programs

September 2: Hunt Conrad – Bikes, Brats & Beer

Hunt Conrad presented his proposal to the club membership for a new fund raising project, to be scheduled for September 2015. The project is a bicycle event to be held in



conjunction with the Soroptimist Beerfest, with a proposed name: Bikes - Brats & Beer. The event would be similar to the Healdsburg Chamber of Commerce *Harvest Century Bike Tour* planned for the spring. Course lengths options would be about 30, 60 or 100 miles. The event could include up to 300 riders and proceeds could be as high as \$30,000.

The membership was generally favorable to the proposal, however, recognizing the huge commitment, a great deal of investigation and planning is needed before a go/no go decision can be made. The upfront costs would be substantial and the advanced planning and organization would be a large effort. A strong committee chair is required.

September 9: Bear Republic Brewery

Fellow Kiwanian Richard Norgrove of Bear Republic Brewing Company invited the club to tour the brewery in Cloverdale on September 9. The Factory Five Brewery was opened in Cloverdale in 2006, the company having outgrown the original brewpub in Healdsburg.

Beer, at a glance, is very simple: Water, hops, malt, yeast. And at Bear Republic, more hops! However, the process of producing premium beer from these ingredients is far from simple as we discovered on the tour. The tour, led by Brewmaster Richard Norgrove and Roger Herpst, started at the grain delivery point where

the grain is pumped into a silo for temporary storage. Several special grains are mixed to create different desired flavors and the mixture is crushed together (not ground). The mixture then goes to the mash pump where the conversion to a soluble sugar solution: Wort. The key to the process is temperature and timing. After an 18 to 21 day fermentation and further processing the product goes to the packaging section where it is bottled or put in barrels for shipment.

Bear Republic uses high quality ingredients. About 60 different malts and many different varieties of hops are purchased. Hop content is a key, about 2½ pounds per barrel is typical. The Racer 5 recipe uses 7 different varieties of hops.

September 16: Carla Howell, Executive Director -Healdsburg Chamber of Commerce

Carla Howell, speaker at the September 16 meeting described the Chamber of Commerce

annual Harvest Century Bicycle Tour and provided much useful information for our club's consideration in planning for a similar event.

The Harvest Century Bicycle Tour is in its 28th year and was created to bring people into the area and promote the tourist industry. The event features moderately challenging rides



through the Alexander, Dry Creek & Russian River Valleys. Distance options include 23, 37 or 60 miles; gradually increasing in difficulty. The event has always been run in July but the Chamber is considering an April or early May date for next year.

There were about 650 riders last year. The event typically raises about \$30,000 to \$50,000. The upfront costs are about \$10,000 and include permitting, insurance, signage and other miscellaneous costs. A ticketing agency is contracted to handle sales and distribution of tickets, greatly reducing Chamber Staff effort. The staff still must devote many hours for planning and preparation for the tour.

Interclub "Round Robin" Completed

The interclub "Round Robin" was completed for the 2013/14 year with a visit to the Fort Bragg club on September 16, attended by Loretta and Jerry Strong, Rick Anixter and Dorothy Colloran. Loretta noted that the Ft. Bragg club is really struggling to maintain its membership which has fallen to just eight members and that the meeting organization was noticeably different from past meetings.
